2	Onetime online Registration and <b>Round 1</b> choice filling and saving of the filled choices online, in order of preferences by the successfully paid candidates.	From 6 PM of 10 <sup>th</sup> November 2020 till 11:59 PM of 12 <sup>th</sup> November 2020 as per server time	3 days
3	<b>Round 1</b> online choice locking of the saved choices in order of preferences by the successfully registered candidates. Choices once locked cannot be modified. If candidate fails to lock choices then system shall auto-lock such choices after the choice locking period is over. 4	Publication of the enrolled and successfully paid Candidate list for WB UG 2020 counseling [ It must be kept in mind that only the Locked choices of the successfully registered candidates shall be considered for allotment as per inter se merit and State of WB policy]. (This list is purely provisional since candidature can only be finalized after original document is physically verified)	13 <sup>th</sup> November 2020 after 6 PM	1 day

7	<p>The physical reporting of the allotted candidates to the respective allotted colleges along with fee and original documents and bond for admission after successful document verification.</p> <p>If the candidate fails during document verification, then the allotment shall be cancelled.</p> <p>The candidate may be considered in the subsequent round with necessary modification of candidature as per document verification at the allotted college provided such candidate still remains eligible with the altered status.</p> <p>However, if it is found that candidate has deliberately tried to provide mis information or falsification or fabrication of documents or obtained unfair means then the candidature shall be cancelled at once and the candidate cannot participate further in counseling process of WB UG 2020.</p> <p>The NRI candidates have to verify centrally at First as indicated in Sl. No 6 above and only the Successfully verified candidates can move to respective allotted colleges for admission with Requisite fee, bond and documents in original.</p>	From 10 AM till 4 PM of 17 <sup>th</sup> and 18 <sup>th</sup> November 2020 as per server time	2 days
